#### MOWGLI STREET FOOD TERMS & CONDITIONS

Full venue exclusive hire

#### **Room Hire**

This is the amount quoted and contracted for Exclusive Full Venue Hire within the times agreed on your booking form. The hire fee covers the full use of the venue including all private rooms but not back of house, and staffing of your event.

#### **Minimum Spend**

This is the amount quoted and contracted to be the minimum amount spent on food, beverage or Mowgli Street Food merchandise. Your spend may go over the minimum spend but it cannot go under. Prepayment of at least the Minimum spend amount is requires as payment or guarantee prior to your event date. In the event the minimum spend is not met, no refunds will be issued nor will any balance be transferred to another booking.

#### Cash bar sales or Pay As You Drink

Cash bar or "Pay as you drink" sales made during an event can count towards the Minimum spend with prior approval from venue management. If cash bar sales do not reach the agreed Minimum Spend, the shortfall will be deducted from the pre-paid Minimum Spend. Any refunds due will be issued using the original payment method Mowgli Street Food are legally prohibited from selling any beverages which will be consumed off site.

#### **Event Confirmation & Deposit**

Your booking is considered provisional until Mowgli Street Food receives a signed booking form within 48 hours of the date if sending and a payment of 50% of the Total Quotation amount: Room Hire & Minimum Spend, is made. This is required immediately upon receipt of the booking form or within 14 days of the invoice date. Mowgli Street Food advise you not to make any firm plans until you receive confirmation of your booking via email from your Event Manger.

#### **Final Payment**

Your final spend payment - less 50% deposit already paid, is due 14 days prior to your Exclusive Full Venue Event date. Changes may be made up to 7 days prior to your event date however the guest numbers given at the 14 day mark will be final and only slight preorder changes, positive increments in guest numbers and additional sales will be allowed at this point. If you are paying by bank transfer, we will require your payment run dates to ensure the balance is paid in a timely manner.

#### Agents

Where the Initial Enquiring Contact is acting as an Agent for the Principal Client, Mowgli Street Food requires a written confirmation from the Principal Client that the Agent is empowered to contract with Mowgli Street Food on the Principal Client's behalf and the Principal Client will accept all additional charges involved. Failure to do so will result in the Agent being liable and responsible for covering any additional costs incurred by their client.

#### **Catering Pre-Order**

Your food and beverage pre-order is due 28 days before your event. Please email your requirements to your Events Mangers by the set deadline. Should you not submit your order by the deadline, we shall by default serve the Sharing menu or equivalent package for the entire group, based on the number of confirmed number of guests confirmed on the booking form. Package prices may vary in December.

#### Corkage

Corkage Should you wish to provide your own beverages for your event, please ask your Event Manager about corkage rates at least 2 weeks ahead of your event. Where Mowgli Street Food agrees to corkage, a pre-agreed fee per bottle will be confirmed by your Event Manager. The corkage fee(s) will be redeemed against your contracted Minimum Spend.

#### Service Charge

Our team will always work hard to ensure you enjoy your experience with us! A discretionary service charge of 10% will be added to the Final Spend – Less the Room Hire. This amount will appear on your event function sheet once your pre-order is submitted. Service charge will also appear on the bill in the venue at the close of the event and reflect the actual spend on the day. Should you opt not to pay service, please let your Event Manager know in advance, or tell your server at the close of the event. Service charge is calculated only against food and beverage.
